Example Hurricane Harvey highlighted that the affected PSAPs were in desperate need from other elements other than just TERT (i.e. donations money to be distributed). Important for members at the State level that wish to create a mechanism to receive and distribute monies to be cognizant of fees / costs associated with processing. Of note, most States require registration prior to soliciting or receiving of donations. It's recommend that you make sure you know and agree to any administrative costs or fees and have a contract in place before you accept donations.
 - b. NENA presentation in Nashville-
 - Potentially, there is a TERT presentation that has been accepted for the NENA conference in Nashville however it is unknown who submitted the application. Brian Fontes advised it was Jason Smith that submitted the presentation.

- c. Sharing Information with other states: Jeanine Krull IL-dept. homeland security grant strategic technology reserve incident communications center manager- team leaders took the class. Team leaders are part of a new training committee and spotlighting new team leaders and newsletter.
 - Illinois received a grant from Department of Homeland Security and held an Incident Communication Centre Management training session which was coordinated through Strategic Technology Reserve team. Training resulted in certification for all Team Leaders.
